THE BEGINNINGS

"HERE'S A CHURCH FOR YOU...Liberal in message and spirit...Democratic in government and organization...Designed to serve all denominations...It will provide a church home for Christian people of all backgrounds; a church school for children of all ages; activities, study and fellowship for modern men and women helping them to find the true meaning of their lives in these troubled times."

With these words from the first brochure sent out to people living in the Casas Adobes area, The Casas Adobes Community Congregational Church began its introduction in this community. Much work had already been done before the brochure had ever left the press. In March 1957 a group of members of The First Congregational Church of Tucson had sought for and obtained "comity" from The Tucson Council of Churches in the fast growing northern edge of Tucson. Soon after The Board of Directors of the Congregational Conference of Southern California and the Southwest together with the Home Board of Missions of the Congregational Churches of America voted to help support this new church for an indefinite amount of time. (It might be stated that financial aid was only partial and extended for only two years and a half-the smallest amount of aid ever given to a new Congregational church.) But the concerned people in Casas Adobes had not been inactive.

On May 22, 1958 fourteen people met around the swimming pool of the Joe Nordale residence, 6775 Casas Adobes Road, to discuss the formation of a new church. Mr. Earl Brooks was elected chairman of a Steering Committee to bring their desire for a new church in the Casas Adobes Area into fruition. Subsequent meetings at the home of the chairman, Mr. Earl Brooks at 6740 Casas Adobes Drive, expressed the continuing interest in such a church. On June 19, 1958 102 people met at the Brooks' residence to hear Dr. Jesse F. Perrin, Superintendent of the Congregational Conference of Southern California and the Southwest, explain the procedures necessary to undertake such a venture and the support and help that might be expected from the conference.

The first service of worship for the new church was held on Sunday, October 26, 1958 at 11 A.M. in the guest house of the Nordale residence, 6775 Casas Adobes Road. There were 28 persons in attendance. The worship was led and the sermon given by Dr. James E. Robinson, pastor of Visitation of the First Congregational Church, on the subject "This Is Your Life". Dr. Robinson continued to lead these Sunday worship services until November 16th when Dr. Phillip E. Gregory, retired minister of the First Congregational Church of Laguna Beach, California, came to be interim pastor. Immediately Dr. Gregory and his gracious wife Harriett endeared themselves to the worshippers and attendance continued to grow. Soon the guest house on the Nordale properties was not large enough and services were changed to the garage of the Earl Brooks' residence, 6740 Casas Adobes Drive. Lillian Brooks personally scrubbed and polished the garage floor each Saturday that worship might be held there the next day. On Christmas Sunday, December 21, 1958, 104 people were in attendance.

By this time the interested people had formed a temporary organization.

A Church Council held monthly meetings to take care of the business of the growing church. Members of the Council were: Mr. Earl Brooks, moderator; Mrs. Earl Brooks, clerk; Mr. Paul J. Hewitt, treasurer; Miss Martha Goodwin, financial secretary; Mr. D. E. Gamble, chairman of the Trustees; Mr. F. E. Busemann, chairman of the Diaconate; Mr. Joseph Nordale, chairman of the Building Committee; Mr. Martin Paulsen, auditor; Mrs. R. E. Busemann, chairman of Fellowship; Mr. William Haselton, chairman of publicity; and Mrs. C. C. Simons, coordinator of Women's Work.

Two matters were items of growing concern with the new church. First, a permanent place to worship had to be found and, second, the choice of the first regular pastor had to be made. Dr. Gregory had asked to be relieved of his duties by February 15, 1959 and the garage at the Brooks' home was fast becoming too small. On January 5th Mrs. Joseph Nordale, chairman of the Pastoral Committee, wrote the Reverend George C. Vance, pastor of the First Congregational Church of Tucson, inviting him on behalf of the Pastoral Committee and the Church Council to become the first regular pastor of The Casas Adobes Community Congregational Church. On January 12th Mr. Vance, in a "letter of intent", stated that his resignation was in the hands of the Council of The First Congregational Church and if released from his obligation at First Church he would be pleased to accept the invitation. This release was granted and he came to the pastorate of the church on February 16, 1959.

The problem of a permanent place to worship and to hold church activities was also solved about the same time. At a Council meeting held on February 12, 1959, Dr. William Newman, Director of The Church Building Society of The Congregational Churches, announced that his board had purchased, in the name of the church, the Nanini-Nordale properties at 6775 Casas Adobes Road. (Since the church was not an official organization it could not enter into contract for such properties.) The Council voted to accept the transaction, and to assume the mortgages covering the purchase price of \$100,000. The seller, Mr. Sam Nanini, gave a \$25,000 gift to the church payable in five years.

And so after a very successful interim pastorate of three months, Dr. Gregory and his wife Harriett were graciously feted at a farewell party held at the C. C. Simmons residence on Sunday afternoon, February 15th. And on February 17th The Reverend George C. Vance and his wife Geri and son Arthur David moved into the present properties. The first service of worship was conducted by Rev. Vance in the living room of the Nanini apartment on February 22, 1959 at 11 A.M. Sunday School also met for the first time that Sunday. Three Departments were convened: the Pre-school, taught by Mrs. Joseph Nordale; grades one through four, taught by Mrs. W. S. Mason; and grades five through eight led by Mr. William Meteer. The attendance at Sunday school on that first Sunday was fifteen. However, by April 7th the records showed that 55 children were enrolled in our Sunday School: 12 in Pre-school; 17 in grades 1 through 4; and 26 in grades 5 through 8. By that time we needed a Sunday School superintendent and Mr. William Meteer was appointed to that capacity.

Another first was the inauguration on March 8^{th} of a "Coffee Fellowship" held in the patio of the church at 10:30 A.M. preceding the 11 o'clock service. Mrs. F. E.

Busemann volunteered to head up this activity which has helped so many fine people get acquainted with our church. On Sunday, April 15th, the first meeting of senior high youth was held and a "Pilgrim Fellowship" established, and the following Sunday the junior highs wanted to meet, which they did, and the "Pioneer Fellowship" followed.

For some time the matter of charter membership in the new church was discussed. Dr. Gregory had appointed a committee to approve an "application for membership" and the Council had voted to receive "Charter Members" up and until the Easter Services to be held on Sunday, March 29, 1959. At that time 115 members were received into the fellowship of the new church. A list of these "Charter Members" of the church is found at the close of this history.

The first official business meeting of the church was held at the conclusion of the eleven o'clock worship service on Sunday, April 26, 1959. Three matters were brought before the attention of the membership. The first was a request to petition the Arizona Association of Congregational Churches for membership into that organization; the second was the adoption of temporary bylaws; and the third was the election of officers for the coming year. All three of these matters were necessary in joining the Association and Conference of the Congregational Church. Needless to say, these motions were unanimously passed. The officers elected for the new church were: Moderator, Mr. Earl H. Brooks; Clerk, Mrs. Earl H. Brooks; Scribe, Mrs. Edward Notesteen; Financial Secretary, Miss Martha Goodwin; Treasurer, Mr. Paul Hewitt; Auditor, Mr. Martin Paulsen; Historian, Mrs. William A. Meteer; Chairman of Board of Trustees, Mr. D. E. Gamble; Chairman of Board of Deacons, Mr. F. E. Busemann; Chairman of Board of Christian Education, Mr. W. Day; Superintendent of Sunday School, Mr. W. A. Meteer; Chairman of Committees: Music-Mrs. G. C. Vance, Memorial-Mrs. C. C. McComb, Ushers-Mr. A. H. Holmberg, Hospitality-Mrs. F. E. Busemann, Publicity-Mr. W. D. Hazelton, Women's Fellowship-Mrs. C. C. Simmons.

The following Sunday, May 3rd was another "Red Letter Day" in the life of the new organization. The first "Loyalty Sunday" was held at the morning services where the new members and friends of the church brought their "Declaration of Intention" cards to the altar. On that Sunday forty pledges were received totaling \$9,296.00 of support for the rest of the year. That afternoon The Casas Adobes Community Congregational Church of Tucson was received into the Arizona Association of Congregational Churches. A 6:00 P.M. Buffet Dinner was served around the swimming pool to assembled delegates and members of the church. At 8:00 P.M. the Service of Recognition was conducted. The sermon was preached by The Reverend Culver H. Nelson, pastor of The Church of The Beatitudes of Phoenix. Other ministers taking part in the service were The Reverends James Ord, Waldo S. Richards, Arthur Reinhardt, Ceil Hickman, James E. Robinson, Lester E. Smith, Cecil Prior, John Langenes, and our pastor, the Reverend George C. Vance.

The hum of activity was somewhat diminished during the heat of the summer, but the fall saw the church in full swing once more. The Chancel Choir was organized in early September of 1959 with Mr. T. J. Wilson as its director. Miss

Dorothy Goodwin was our first organist and served until her marriage in October of 1960 to Capt. Alvin Pressley. Mrs. Ralph Manley was appointed organist in the fall of 1960 and has been with us since. Mrs. William Martin followed Mr. Wilson as director of our Chancel Choir until she resigned in the spring of 1961. On July 17, 1961 Mr. Reg Redman was interviewed and hired and he too has faithfully performed his duties since the time of his appointment. In the fall of 1964 a Junior Choir was organized, a Cherub Choir in the winter of 1967-68; and this fall a "Bell Choir" has been formed .

On October 25, 1959 the properties of the church were dedicated and the Dr. Jesse F. Perrin, Superintendent of the Congregational Conference of Southern California and the Southwest, our sponsoring group, was the speaker. In October of 1959 citrus trees and oleanders were removed east of our properties and an opening from Oracle Road was made. This work was made necessary in order that we might have adequate parking.

On November 12th at the home of Dr. Irving Fovargue the first official meeting of the Women's Fellowship was held, with Mrs. Florence Fovargue its first president. The records show that the Women's Fellowship had 43 women in attendance at its May breakfast in 1960 held at the home of Louise Snyder.

There are many other interesting and amusing things that filled the first official year of our recorded history, but time and space prohibit their mention. Suffice it to say that "The Beginnings" were grand and glorious and the path ahead looked to be one of dedication and service.

THE MIDDLE YEARS

The next six years of our church's history were perhaps not as eventful, but certainly not less exciting. Every year had its highlights and its accomplishments. The elected officers of 1960 as well as succeeding years may be ascertained by checking the Officiary List at the end of this historical brochure. The year 1960 opened with the dedication on January 3rd of the new Don Simmons Memorial organ, given to the church by Mr. and Mrs. Clarence Rand all in memory of their grandson. This fine Baldwin organ, with two new speakers, now serves so effectively in our new church. Miss Dorothy Goodwin, our organist, presented an exceptional organ concert and the service of dedication was led by our pastor.

Other significant happenings in 1960 were the incorporation of the church as a non-profit corporation in the State of Arizona on May 17th: the acceptance of the "permanent" (we since have had two other sets) by-laws at a specially called congregational meeting preceded by a "pot luck" supper on April 22nd; and the purchase of robes for our Chancel Choir.

A significant fact faced the Casas Adobes Community Congregational Church in May of 1960, that is, the organization of a sister church, Saint Andrew's Presbyterian, under the leadership of the Rev. Newton White, a resident of the Casas Adobes area. This was the beginning of other churches coming into the area and our attempts of coordination and cooperation together.

The year 1961 saw on January 8th the start of two Sunday worship services, one at 9:30 A .M. to supplement the original 11 o'clock service. Also our





first Youth Sunday was held on the fourth Sunday of January. The speeches were given by John Frannea and Margaret Brownewell, and those leading other parts of the service were Susie Bring, John Crawford and Anne Brownewell.

Membership in the church continued to grow, with 92 members added in 1960 and 88 in 1961. The growing membership, presented problems of space, especially in the church school. The manse, office and garage were over-crowded with children and the living room of the manse was used at least three times a week for board and committee meetings and choir practices. The officiary of the church faced the need of more Sunday school space and additional worship area.

Late in 1961 the Trustees voted to clear the deck for action and to present to the membership a "Funds for the Future" program. The announced goal was to raise \$25,000 in capital funds, payable over a two-year period. Sixteen thousand five hundred dollars would pay up the first mortgage on our present properties; \$7,000 would be used to expand the sanctuary and \$1,500 would be sent to the Conference for its capital expansion fund. Under the direction of Mr. Fritz Baseman and a capable committee the drive was launched in February of 1962 and the guota of \$25,000 in pledges was obtained.

At the close of 1962 the Trustees also solved the problem of additional room for our Sunday School. They voted on December $4^{\rm th}$, with its O.K. at the Annual Meeting, to purchase the Clifford Reising property, 1129 West San Martin Drive, as a home for our pastor at a cost of \$24,500. A \$5,000 down-payment was made on the property and in the latter part of January 1963, the Vances moved from 6775 Casas Adobes Road to the present manse making available for Sunday School use our entire properties .

But circumstances beyond the church's control had slowed the growth of both Sunday School and membership. From May 1960 to September 1964, six new churches had moved into the Casas Adobes area. In May 1960, as heretofore noted, Saint Andrew's Presbyterian Church had been organized and on November 11, 1962 they moved into their new sanctuary on Paseo Del Norte Road. In July of 1961 the Lutheran Church of the Ascension started holding services at Harelson School and in March of 1964 they were in their new church. In the spring of 1962 the Casas Adobes Baptist (Southern) Church was organized and they built a church in the fall of 1966. In late 1962 St. Mark's Methodist Church was moved from Overton and Thornydale Roads to La Canada and Magee and by November 1966 they had a temporary sanctuary available. On April 22, 1962 The Dove of Peace Lutheran Church held its first worship service at Cliff Manor and on April 10, 1966 they used for the first time their new properties. While on September 13, 1964 Christ the King Chapel, a mission of St. Philip's In the Hills Episcopal Church, convened worship services at Harelson School and moved into their new church on West Ina Road on September 14, 1965. So, while in 1959 there was but one church in the Casas Adobes area, there were by 1964 seven churches all asking for the lovalty and membership of the folk of the area. These developments drastically changed the growing plans of the church and in 1963 the Trustees voted not to spend "Funds for the Future" money to expand our present sanctuary, but to form a permanent Long Term Planning Committee to arrive at a

"Master Plan" for our property development. Mr. Earl Brooks and Mr. Ivan Culbertson were subsequent chairmen of this committee, first appointed by the Trustees and later by the Church Council. Serving with them, among others, were Messrs. D. E. Gamble, Fritz Busemann, James Woodruff, Roy Thornton, Sam Nanini, Paul Hewitt, Bill Haselton and Doug McComb. Much preliminary work was done centering around an attempt to purchase land to the north of our properties, but when that failed to materialize the church instructed a newly elected committee consisting of Mr. James Woodruff, chairman, Mr. Sam Nanini, Mr. D. E. Gamble, Mr. Doug McComb, Mrs. Richard Burton and Mrs. D. O. Shaffer to go ahead with a Master Facilities Plan and engage an architect for professional consultation.

A small yet significant event happened in the fall of 1962. Two adult study groups were formed, one on "The Study of The Parables" and the second on "Other Religions". Each served a helpful and significant role in the life of the church, but it was from the "Other Religions" group that came the thrust for our new church and the study which resulted in our new organizational structure. After two years of interesting study and fellowship highlighted by informational talks on the religious faiths of the world and the denominations of Christianity, the group decided it was time to study "Congregationalism"; and so, meeting in the members' homes the group studied how our church was run and the particular problems we faced as a congregation. It might be noted some of the guiding lights of this Adult Study Group were the Joe Biehls, the Harry Claytons, the Floyd Sedlmayrs, the George Vances, the John Rosenbergs, the Ken Lawvers, the Norm Ronnings, the Bill Haucks, Ivan Culbertson, Louise Elliott, Ruth Anderson and many others.

FULFILLMENT AND FUTURE

Out of the "Other Religions" study group came a "Member's Attitude Survey" conducted in our church in the spring of 1966. Financed by an anonymous gift, Dr. Ralph C. Kauffman of the University of Arizona was engaged to conduct the survey. A questionnaire designed by Dr. Kauffman was sent to every adult member of the church. In addition, five cottage meetings were held with attendants representing a cross-section of church membership. Dr. Kauffman sparked an open, informal discussion which was recorded on tape. The tapes were sent to Fry Consultants in Chicago, a firm directed by our own Joe Biehl. Their psychologists analyzed the tapes and reported their findings to our Board of Trustees. Among the conclusions arrived at in this study was that 64% of the members suggested new or changed facilities were required while only 19% thought the present facilities to be adequate.

The second project of the group was the changing of the organizational structure of the church. A brochure explaining the proposed changes was made available to members in the fall of 1966, and at the Annual Meeting Mr. Harry Clayton, moderator, presented the proposed structural chart through a number of colored slides. The congregation voted to accept the proposed changes and have the Articles of Incorporation and the By-laws revised to meet the same. This matter was officially accomplished at a called meeting of the congregation on June 23, 1968.

Meanwhile, the Long Term Planning Committee was busy formalizing a

"Facilities Plan" to present to the congregation. An architect, John L. Mascarena, had been employed. On April 4, 1967 their plans were presented to the congregation. Although the sketch was thought to be too modern and it was requested that it be more in keeping with our present properties, the members voted overwhelmingly to go ahead with a building program by floating a mortgage of not more than \$145,000. A proviso for action was voted to be the rising of \$50,000 in cash and pledges. Mr. William Lyle and Mr. William Chandler were appointed co-chairman of a Finance Committee and on June 10th they reported that the proviso had been met. On December 1, 1967 the treasurer's report stated that pledges totaling \$64,208, from 118 members and friends had been received.

Mr. R. R. Secor became chairman of The Building Committee. Twenty-seven members made up six sub-committees which helped in various ways to make the new buildings become a reality. Members of The Building Committee were as follows: R. R. Secor, General Chairman; Architectural Committee: Barton Marshall, Chairman, Betty Barnes, Ted Gamble, Joe Howe, Jeannette Manley, Lloyd Roberts, Russ Secor, and Jim Woodruff; Interior Committee: Bea Rigney, Chairman, Fred Bullard, Fred Johnson, Betty Barker, Reg Redman, Geri Vance, and Jeannette Manley as liaison from the Architectural Committee. Landscape and Site Improvement Committee: Howard Franks, Chairman, Dick Burton, Ken Lawver, Doug McComb and Bill Chandler; Liaison and Public Relations Committee: Marie Biehl, Chairman and Joe Howe. Mechanical and Electrical Committee: Bernie Weideman, Chairman, Noel Hartshorne and Bill Schubert. Prime Committee: Russ Secor Chairman, Betty Barnes, Howard Franks, Bernie Weideman, Marie Biehl, Bea Rigney and Barton Marshall.

By the end of October 1967 the committees had finished their jobs and on November 27th bids were received. The next day, November 28th, the Trustees awarded the contract to the low bidder, The W. F. Conelly Construction Company. Demolition of the three old buildings, the office, the apartment and the utility room, together with the filling of the swimming pool, was done by Gerson Demolition Company and completed on December 28th. Construction started on January 10, 1968 and the building was occupied for the first time on Sunday, August 11, 1968. Groundbreaking ceremonies had been held on Sunday, December 24th, 1967 following the 9:30 A.M worship service. Besides the Chancel Choir, those participating in the services included Mr. Harry Clayton, moderator, Mr. Floyd Sedlmayr, chairman of the Trustees, Mr. Russell Secor, chairman of the Building Committee, Paul Chandler, president of Pilgrim Fellow ship, and the pastor, the Rev. George C. Vance.

And so with fine new properties and with the tenth anniversary of our first worship service being celebrated, The Casas Adobes Community Congregational Church of Tucson looks to the future. All the fine and interesting past is prelude. The melody to become God's people truly begins. We can make of it a glorious symphony if we will.
